Students attending the "D'Arcy McGee HS Ski Trip" will be staying at Chalets Montmorency Condos. The condominiums are fully equipped with a complete kitchen, dishwasher, microwave and fireplace. Each two-bedroom unit accommodates 6 persons, each three-bedroom unit accommodates 8 persons. The condo complex offers a pool and hot-tub facility. There is a free shuttle service to/from Mont Ste. Anne.

All students can receive a 90 minute skill improvement session (group lesson) the first day of the trip. Students must pre-register for these lessons.

All students must wear helmets while skiing and riding. Experienced students can gain access to the Ste. Anne Snow Park provided certain forms are completed in advance and signed by the parent or guardian (get forms from the Mont Ste. Anne web site). Snow Park passes cost \$20 additional.

One meal will be provided (supper on Friday). Lunch meals can be purchased in the ski centre cafeterias.
